Join TABC staff by videoconference for a stakeholder meeting to discuss draft rules as a result of the agency's implementation of new laws and quadrennial rule review and marketing practices advisories (MPAs).

## Agenda:

- **Item 1.** Revisions to Rule 33.94, Reporting Permit or License Changes, and repeal of Rule 41.48, Changes Relating to Control.
- **Item 2.** Revisions to Rule 33.78, Nonprofit Entity Temporary Events, to restore authority of an NT permit holder to conduct an auction at a licensed premises.
- **Item 3.** New Rule 33.81, Purchase of Wine or Malt Beverages for a Temporary Event, to clarify, for MBs and Ns, the source of malt beverages and wine for temporary events in a county different than the county of the primary premise.
- **Item 4.** Revisions to Rule 45.117 to apply practice to rule of authorizing wholesalers to furnish signs to retailers, which aligns with authority in Rule 45.113 for distributors and brewers authorized to furnish signs to retailers. These changes support guidance provided in the e-commerce advisory.
- **Item 5. UPDATE:** Revised version of new E-Commerce Platforms advisory. TABC staff will provide a brief overview of the major changes featured in version 2 of this draft advisory; however, TABC will schedule a separate stakeholder meeting on this advisory in the coming weeks in order to give stakeholders proper time to review the latest draft and provide TABC with thoughtful comments.
- **Item 6.** Minor update to Cash and Credit Law Requirements advisory (MPA065) last updated in September 2021. The table was updated to reflect the correct timeline and verbiage was added from related rules to clarify the timing of certain activities.
- **Item 7.** Revisions to Infusion of Vodka and/or Other Distilled Spirits advisory (MPA15) from June 2005.
- **Item 8.** Repeal of TABC Expands Collaborative Effort with Comptroller's Office to Collect Delinquent Taxes (MPA041). The advisory was issued in 2010 and is an announcement rather than an advisory on marketing practices.

It is TABC's intent to recommend the rules for publication at the commission meeting in July. All draft rules and advisories are attached.
