Join TABC staff by videoconference to discuss draft rules and advisories as a result of the agency's implementation of new laws and management actions.

## Potential draft rules and advisories for publication:

- Item 1. Reorganization and revisions to Ch. 41, Auditing, including NEW Rule 41.16, Tamper-proof Containers. A crosswalk of current and proposed rules is included as a guide as well as a redlined and clean version of proposed changes.
- Item 2. Amended Rule 33.94 to incorporate existing Rule 41.48.
- Item 3. A new draft advisory for Cash and Credit Law that consolidates seven existing advisories. The advisory will also reflect published changes to Rule 45.130 (Credit Law) and 45.131 (Cash Law) and other changes effective Sept. 1.
- Item 4. Amendments to Certain Nonprofit Entities Serving Alcoholic Beverages at Events advisory currently
  known as Marketing Practices Advisory MPA026 Charitable, Religious, or Civic Organizations Serving Alcoholic
  Beverages at Fundraising Events. The amended advisory reflects new and published changes to Rules 33.78,
  33.79, and 45.103. The draft also mirrors charitable events guidance that is currently published in the Limits on
  Wine Festival Event Activities advisory.

It is TABC's intent to propose the attached rules (Items 1 and 2) for publication at the commission meeting in September. All draft rules and advisories are attached.
